**K**ensington Market is an open-air food and clothing market in downtown Toronto. Since the 1850s, the area has seen different waves of newcomers, from upper-middle class British settler Victorian families (mid-19th century), to Jewish and Italian immigrants (mid-19th to early-20th centuries), Portuguese immigrants (1950s), Indian, Chinese, Korean, Vietnamese and Filipino immigrants (1970s), and Latin American refugees (late 1980s).

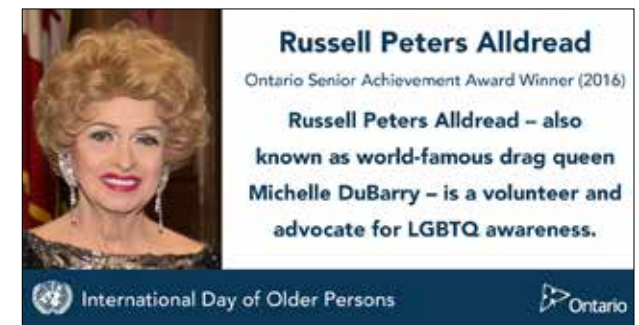
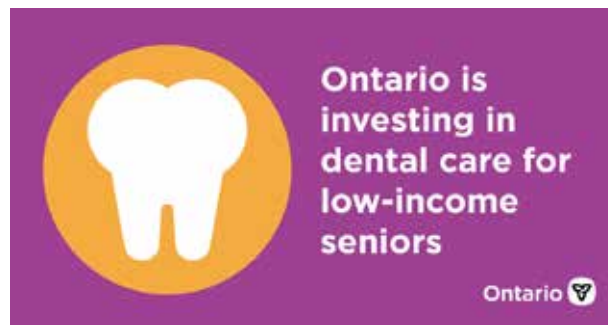

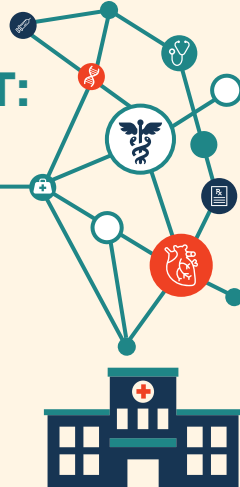

### REFUGEE RESETTLEMENT: HEALTH

Resettled refugees often arrive with complex health needs and sometimes prolonged periods without adequate health care

The socio-economic profile of refugees indicates that many may have higher health risk according to the Social Determinants of Health framework



#### COMPLEX HEALTH NEEDS

Government-Assisted Refugees (GARs) tend to have **more complex health needs** than other immigrants and refugees

**Government-assisted refugees vs. privately-sponsored refugees with "moderate to high" comorbidity**

(The presence of one or more additional diseases or disorders co-occurring with a primary disease or disorder)

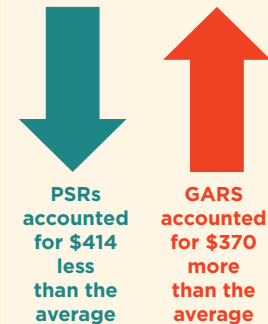

#### COSTS

Adjusted for age and sex, **all categories of immigrants and refugees cost the healthcare system less per capita than 'long-term residents'** with the exception of GARs



The average cost of health care per person in 2017 was \$2,452

#### PRIMARY CARE

Ontario does a fairly good job **ensuring immediate access to primary care** for resettled refugees



Over 80% of all resettled refugees visit a physician in their first year in Canada

20% of GARs

16% of PSRs

used an emergency department in their first year in Canada

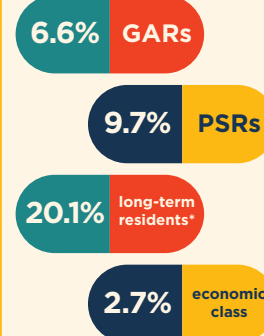

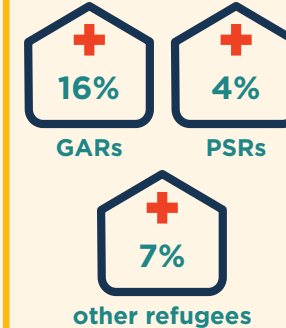

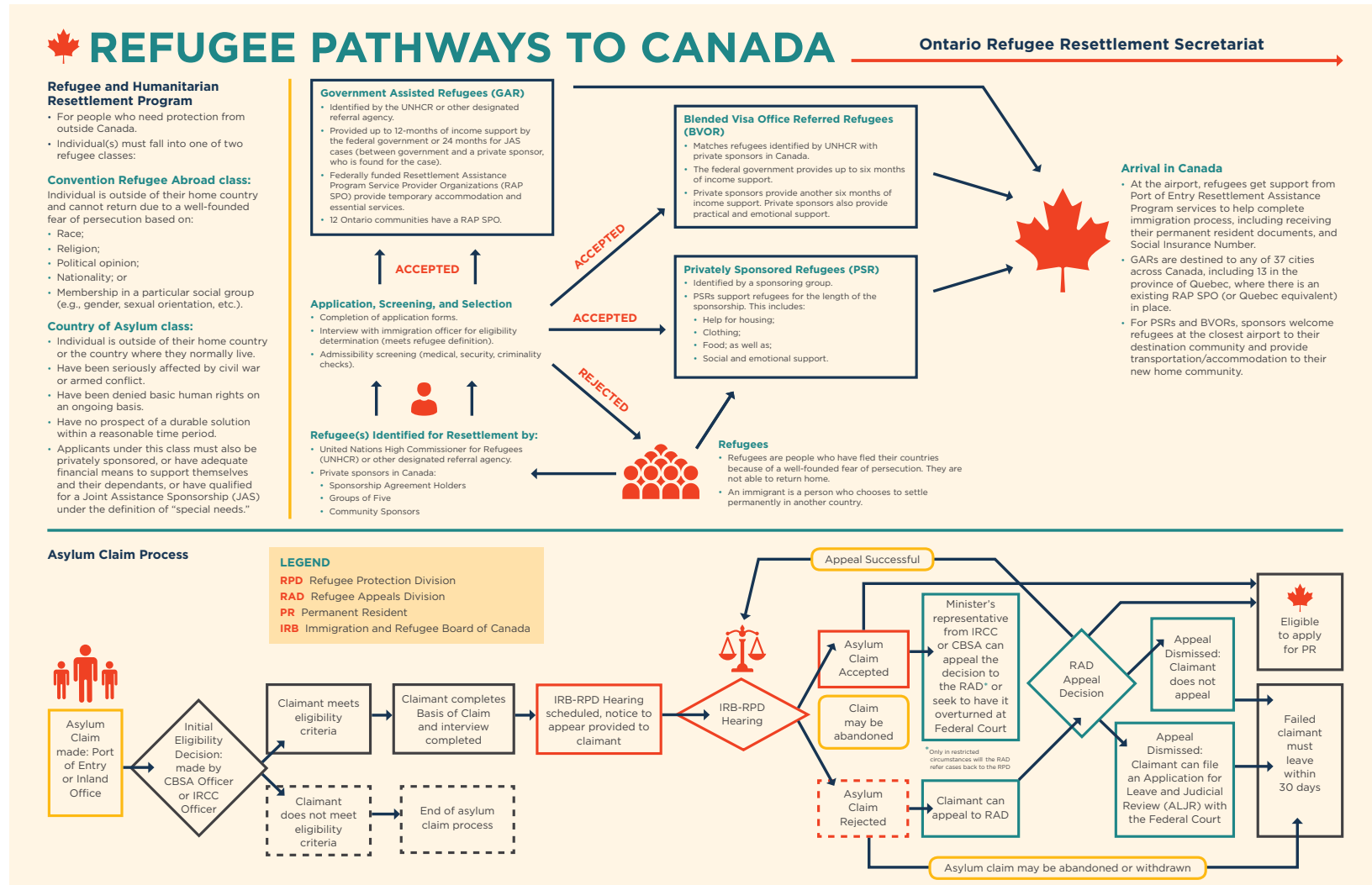
